ACCESS TO STARS

The Stanford Training and Registration System (STARS) is available via the Axxess Portal at <https://axess.stanford.edu>. A SUNet ID is required to login (see below).

HOW TO REGISTER

1. Login to Axxess by going to <https://axess.stanford.edu> and clicking the **Login** button.
2. After logging in, click on the **STARS (Training)** tab at the top of the page.
3. From the *STARS Home Page*, type the word “**animal**” or “**VSC**” into the **Search Catalog** field and click on the **yellow Search button**.
4. Select the **Working Safely with Biohazardous Agents in Laboratory Animals” Program (VSC-PROG-004)** by clicking on the **yellow Continue button**.
5. The next page will list the two parts to this training program. The first part, **Working at Animal Biosafety Level 2**, is a 20 minute web-based video reviewing general practices to follow (courtesy of the American Biological Safety Association). This is followed by **Working with Biohazardous Agents in Stanford’s Animal Facilities**, a meeting with personnel from the Veterinary Service Center (VSC) and Environmental Health and Safety (EH&S) to review safe practices specific to particular studies or animal facilities.
6. To register for the program click on the **yellow Register button** at the bottom of the page.
7. To launch the web-based video, **Working at Animal Biosafety Level 2**, go to your STARS *Learning Home Page*:
 - a. Log onto Axxess, <https://axess.stanford.edu/>
 - b. Select the **STARS (Training)** tab at the top of the page.
 - c. Select **My Learning** in the left margin.
 - d. This should list all programs & activities that you’ve enrolled in, completed, etc.
 - e. Find **Working at Animal Biosafety Level 2** and select the **yellow Launch button**.
8. **To complete the program**, contact VSC Training Coordinator at vsc_training@lists.stanford.edu to schedule a meeting with the VSC and EH&S to review safe practices with your lab (**Working with Biohazardous Agents in Stanford’s Animal Facilities**).
