Senior Associate Vice Provost for Health Education Professor, Pediatrics Stanford University School of Medicine

Dr. Charles Prober, MD is the Founding Executive Director of the Stanford Center for Health Education and Senior Associate Vice Provost for Health Education at Stanford University. He is a Professor of Pediatrics, Microbiology and Immunology. He is an expert in pediatric infectious diseases with an academic career focused on the epidemiology, pathophysiology, prevention, and treatment of infections in children.

Dr. Prober has been involved in medical education throughout his career. He directed a number of undergraduate and graduate student courses in the classroom and at the bedside, He has served as Associate Chair for Education for the Department of Pediatrics and Senior Associate Dean for Medical Education at the School of Medicine (2007-2017). He has lectured locally, nationally, and internationally on infectious diseases and medical education.
