
Stanford Children's Health Epic Access for Research Personnel

Instructions: Follow these instructions for all new University or LPCH research personnel who need access to (or modification/renewal of) LPCH Epic access *for research purposes*.

Process Description: University or LPCH research personnel must submit an [Online Request](#) followed by completion of an Attestation by the supervisor or PI (Steps 1 and 2 below). Once these are complete, the request will route for approval by Authorized Approver in order to access LPCH Epic, the Stanford Children's Health electronic health record (EHR). A separate Online Request must be submitted per user. *Default access is view-only. For research RN or NP, documentation access may be requested in the [Online Request](#).*

Who Must Use This Process?

- Stanford University or hospital research personnel who need access to the LPCH EHR
- Requesters who would otherwise obtain Epic access for clinical purposes should ***not*** request access through Stanford Child Health Research Institute

To Request Epic Access for Research Personnel, follow this 3-step process:

STEP 1: Submit Online Request

Submit an Online Request [here](#).

- Requester will be asked to upload 3 documents:
 1. [CITI](#) Certificate of Completion dated within the last 3 years
 2. [HIPAA](#) "Protecting Patient Privacy" Certificate of Completion dated within the last year
 3. [HIPAA](#) "Privacy for Researchers" Certificate of Completion dated within the last year
- To download **CITI and HIPAA** certificates of completion:

STEP 2: Supervisor or PI Completes Attestation

Once the Online Request (Step 1) is reviewed and verified, a *unique Attestation link and Code* will be emailed from LPCHResearchEpic@stanford.edu to the Supervisor or PI with the subject line "Action Required: Attestation for LPCH Epic Access: [user]." The attestation link is SUNet authenticated and must be completed by the Supervisor or PI. The link leads to the following attestation:

- I, _____ (supervisor or PI), attest that _____ (research personnel member):
- Is a member of the Stanford University or LPCH workforce who has a clinical research job function (e.g. clinical research coordinator, research nurse, research assistant)
 - Has completed the following required trainings
 1. [CITI](#) within the last 3 years
 2. [HIPAA](#) "Protecting Patient Privacy" within the last year
 3. [HIPAA](#) "Protecting Patient Privacy for Clinical Researchers" or HIPAA "Privacy for Researchers" within the last year
 - Will access patient records only for clinical research purposes.

I further attest that:

- My research needs cannot be fulfilled by the capabilities of STARR (formerly STRIDE)
- I assume full responsibility for ensuring that the User utilizes EPIC only for IRB-approved protocol(s)
- I understand access is granted up to one year from the date of request and that a Renewal Online Request and Attestation must be submitted to renew access

STEP 3: User and Manager Receive Log-in Information

Once the Attestation is complete (Step 2), the request will be processed by LPCH Epic Access Control. The Username and Password will be emailed to the user and manager listed in the Online Request Form.

OTHER INFORMATION

Timeline: After the [Online Request](#) (Step 1) and Attestation (Step 2) have been completed, **allow 3-5 business days** for receipt of log-in information to be emailed from Access Control to the user and manager listed in the Online Request.

EMR Access Request (Formerly STARR/STRIDE) (Stanford Medicine Research Data Repository): All personnel requesting access to Stanford Children’s Epic for chart review purposes must obtain a “EMR Access Privilege Letter” or have had one within 1 year of request prior to requesting Epic. [For personnel supporting a Clinical Trial, please note that this step is not required.] To open an EMR Access consultation request go to <https://med.stanford.edu/ric.html> and click on the "Request a consultation" button.

Please note that only one EMR Access consult is required per study. However, each team member will need to complete the following compliance requirements prior to requesting Epic:

1. IRB Approval
2. Privacy Attestation

Syngo Radiology – Radiology ultrasound studies (including PDC) are stored in this system. There is no link from Epic to “Syngo Radiology” and access is not included with your general Epic access. Access for Syngo Radiology can be requested through this route. Please select “True” if you need this access. If “True,” the Supervisor/PI will be asked to explain why this access is needed in the attestation (step 2).

Note:

Syngo Cardiology – Stores sonogram of the heart (Echocardiography) done using special Doppler Ultrasound machines. This access is included in your general Epic access; the data can be accessed via EPIC using the web icon “Echocardiography PACS” in patient chart. (The data will be specific to the particular patient whose chart you have opened in epic.)

Renewal/Modification: Access is granted for up to one year and renewable on a yearly basis. Follow the same 3-Step process above for renewal or modification requests. Users will receive expiry email notices at 30 and 7 days prior to access end date.

Termination: For users leaving Stanford and have Epic access, supervisors should submit a termination request [here](#).
