The Department of Humanities at the Penn State College of Medicine announces a one-week autumn colloquium for professionals interested in the medical humanities. We invite applications from teachers and scholars in various humanities disciplines (broadly defined, including visual and performing arts and social sciences) and in medical education who teach—or plan to teach—courses in the medical humanities to undergraduate, graduate or medical students.

The Penn State College of Medicine Department of Humanities is the oldest humanities department in a college of medicine in the country. With curriculum integrated into all four years of medical school, and deep experience working closely with physicians and other health professionals, department faculty have been on the vanguard of introducing pedagogical and scholarly innovations and are eager to help others with similar interests.

The Colloquium is limited to 6 participants who will be selected on the basis of proposals for research projects or new courses dealing with some aspect of medical humanities. While in Hershey, Penn State Medical Humanities Scholars will work individually with a mentor who has expertise in the area of study*, and collectively with one another.

The Penn State Medical Humanities Scholars will have the opportunity to continue working with their mentors during the subsequent year to develop the final version of their projects.

Each Scholar will be awarded a full scholarship to cover travel expenses, lodging and meals for the duration of the Colloquium.
