The Department of Psychiatry and Behavioral Science at Stanford University School of Medicine is seeking a full time Geropsychologist on the Clinical Educator Line at the Clinical Assistant or Clinical Associate level. Faculty rank will be commensurate with the qualifications and expertise of the successful candidate. The position is available immediately for outpatient services emphasizing primary care of geriatric patients with complex psychiatric and neurocognitive needs at Stanford University Department of Psychiatry and Behavioral Sciences Geropsychiatry Clinic and the Stanford Senior Care Clinic.

Qualified applicants will have a degree from an APA-approved Ph.D. or Psy.D. program in clinical or counseling psychology, including coursework in geropsychology; must be licensed or license-eligible as a Psychologist in CA. Completion of an APA approved internship, including rotations in geropsychology required, and strong preference will be given to applicants who have completed a postdoctoral fellowship in geropsychology. Demonstrated clinical skills both generally and in the area of geropsychology with specific clinical experience working with older individuals suffering from a range of complex psychiatric and medical comorbidities is required.

The focus of this position is on clinical service, specifically direct patient care with outpatients and their family members as needed. These individuals typically suffer from depression, anxiety disorders, and/or cognitive impairment. There is a preference for candidates with skills administering short-term forms of psychotherapy (such as CBT), group psychotherapy, group psychoeducational programs (e.g., for family caregivers), and family therapy. Our clinic features a well-functioning interdisciplinary team that is committed to working collaboratively. Consultation with the geropsychiatry inpatient treatment teams will be expected. Responsibilities also include training clinical psychology postdoctoral fellows and psychiatry residents in topics related to geriatric mental health. Conducting independent research is not required, although interest and ability to collaborate with other faculty in their research is expected.

The Department of Psychiatry and Behavioral Sciences, School of Medicine, and Stanford University value faculty who are committed to advancing diversity, equity, and inclusion. The pay offered to the selected candidate will be determined based on factors including (but not limited to) the experience and qualifications of the selected candidate including equivalent years in rank, training, internal equity, and external market pay for comparable jobs.
